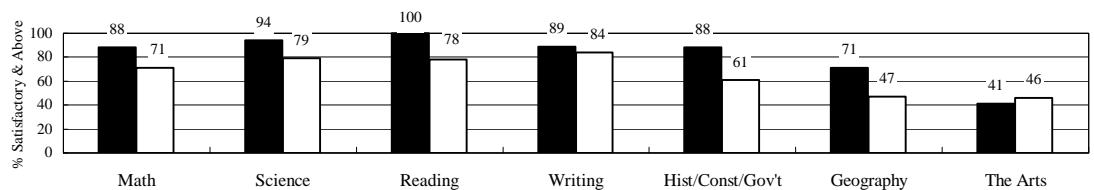

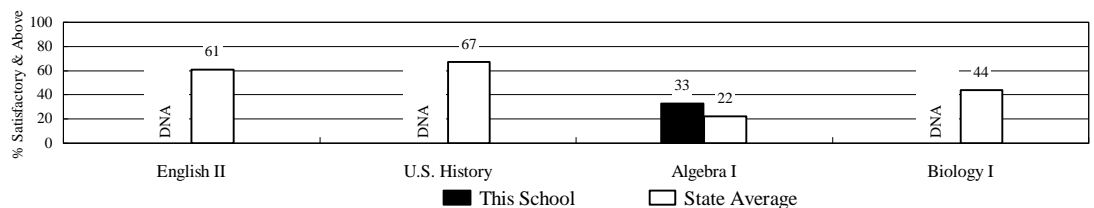
8th Grade Oklahoma Core Curriculum Test - "Regular Ed." Students
