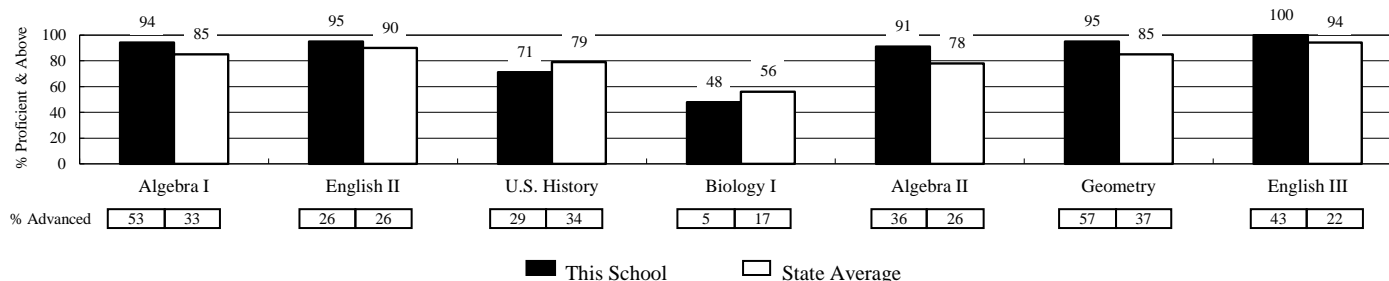

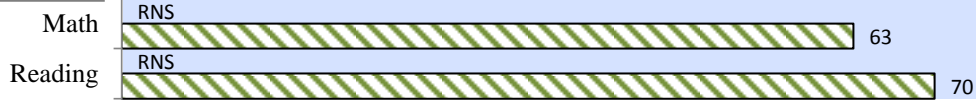

2014-15 Student Performance (All Students, Full Academic Year)

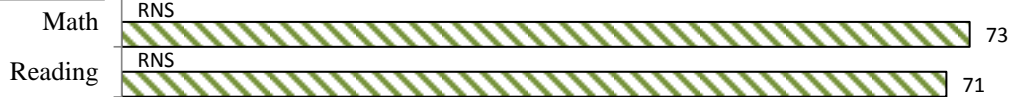
% of Students Scoring Proficient and Above by Grade and Subject

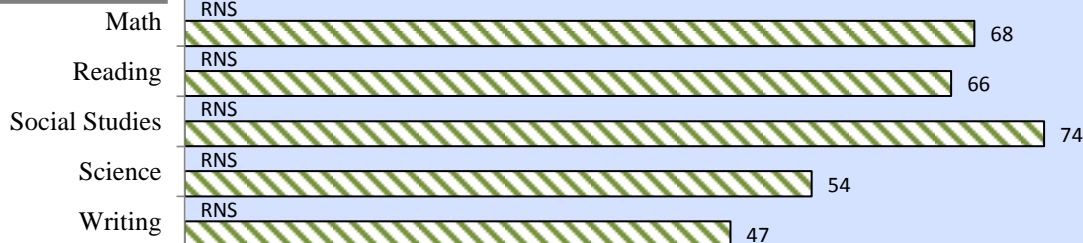

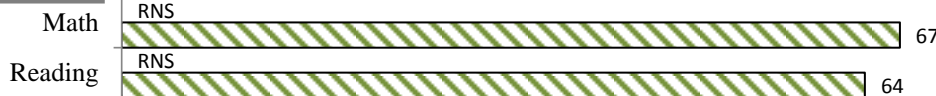
4th Grade Tests

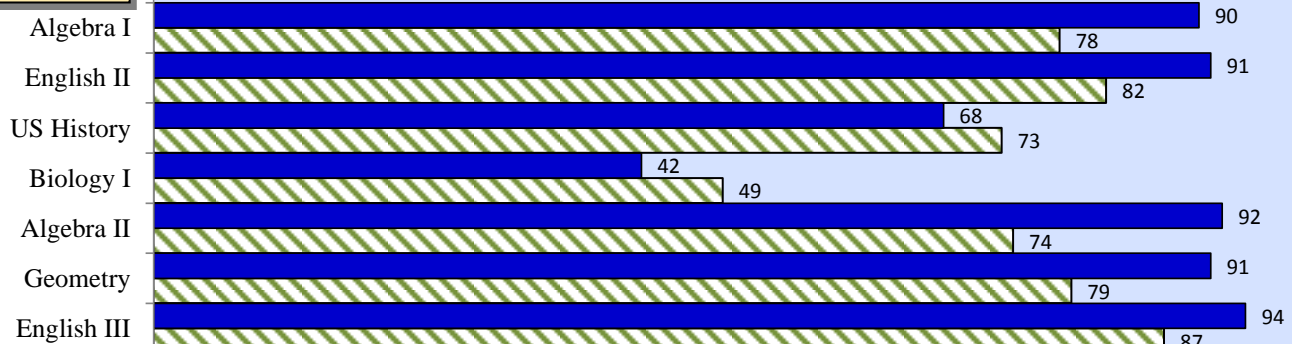
