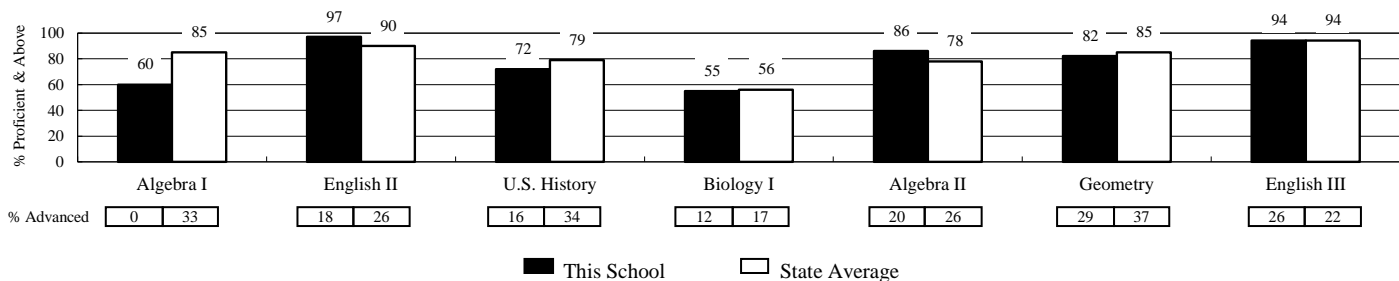

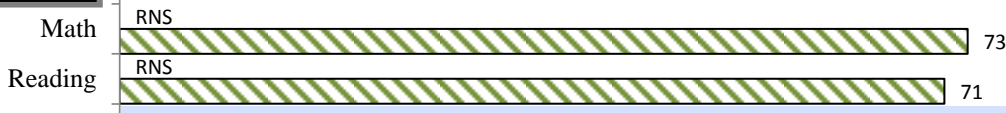
% of Students Scoring Proficient and Above by Grade and Subject

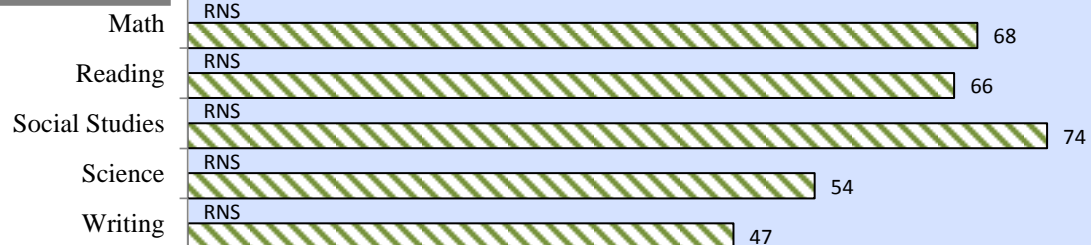

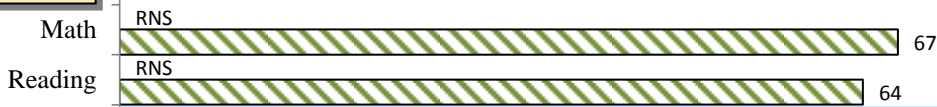
4th Grade Tests

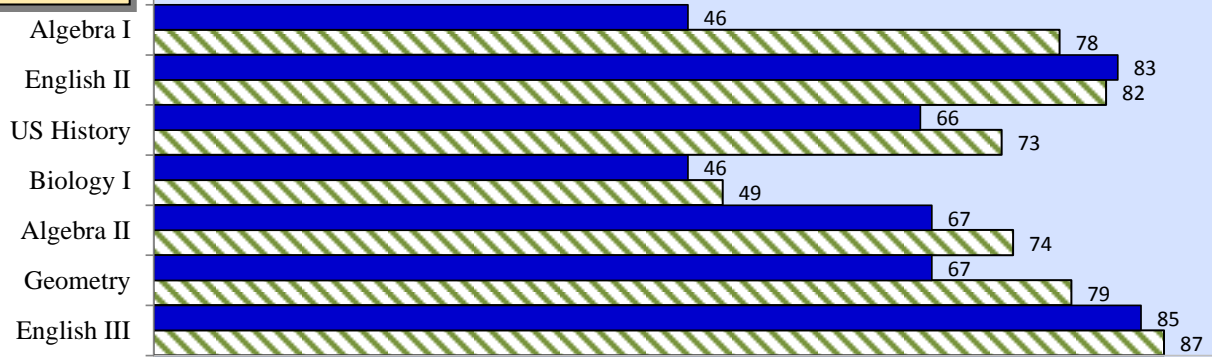
