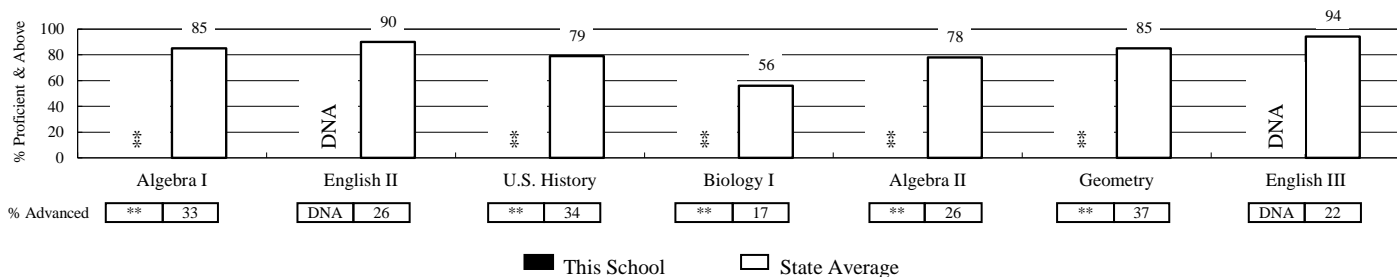

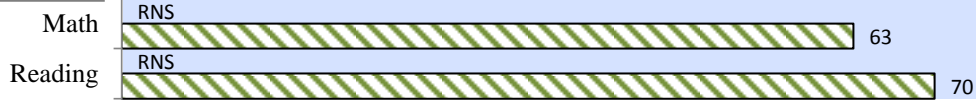

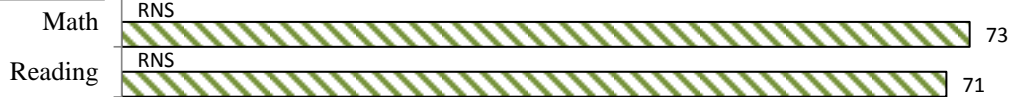
% of Students Scoring Proficient and Above by Grade and Subject

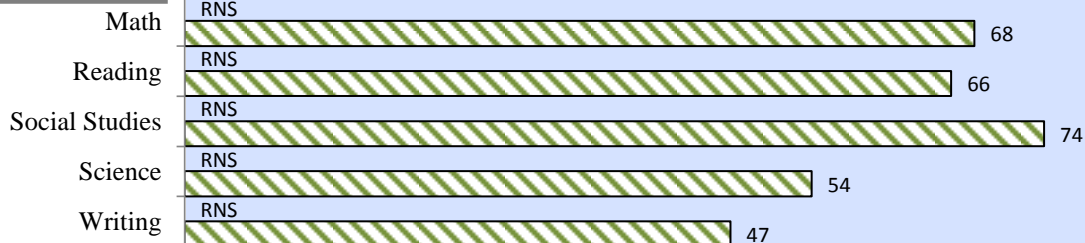
3rd Grade Tests



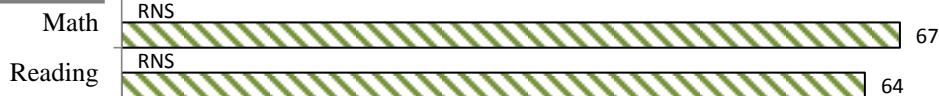
4th Grade Tests

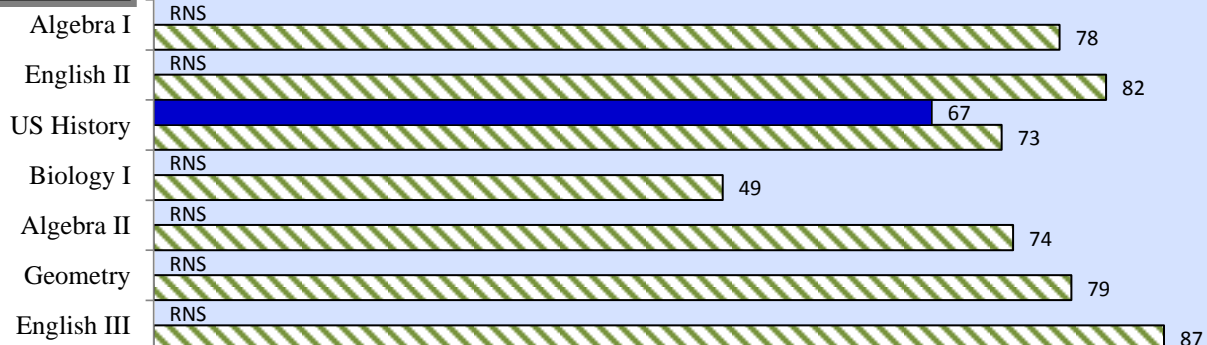
