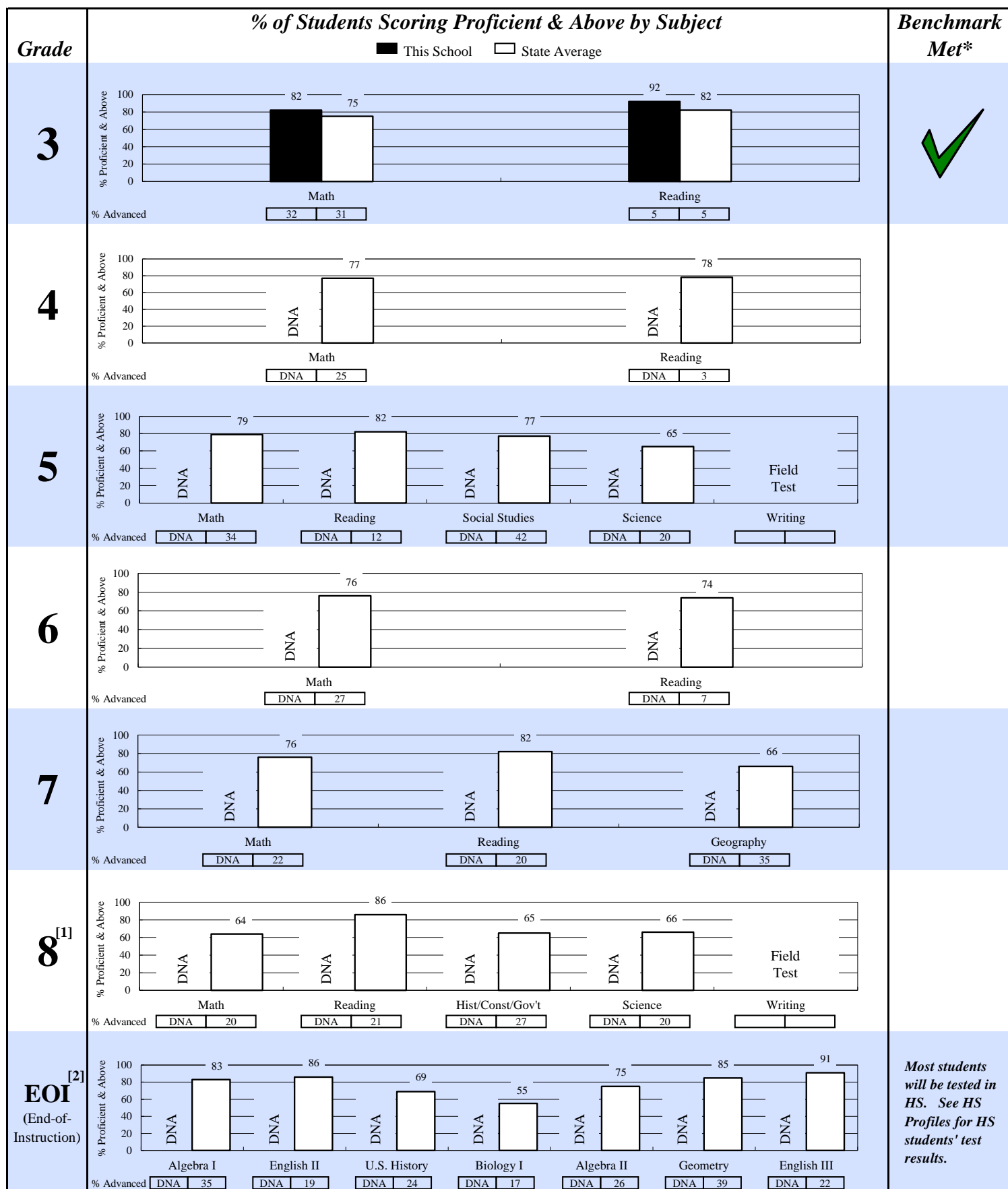

2015-16 Student Performance (All Students, Full Academic Year)

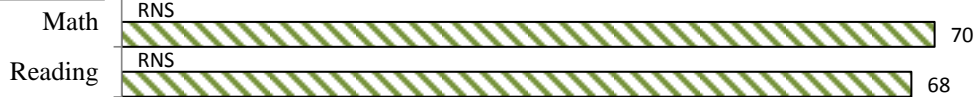
% of Students Scoring Proficient and Above by Grade and Subject

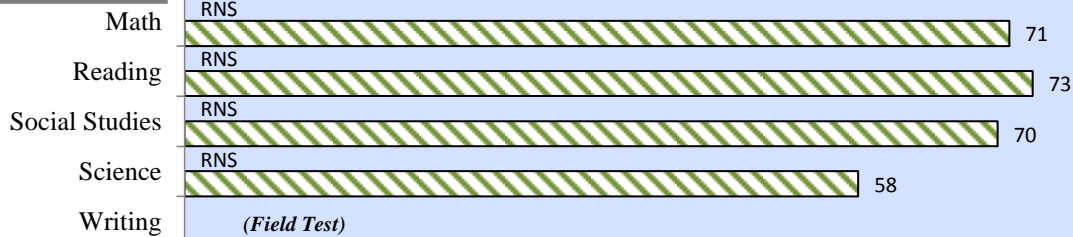

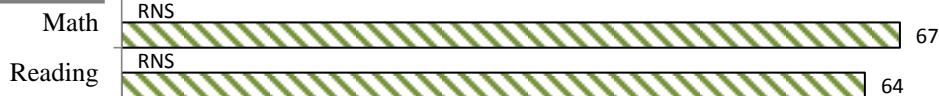
