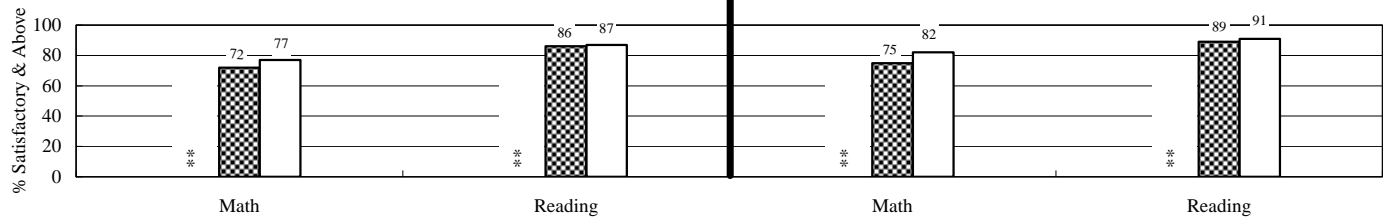

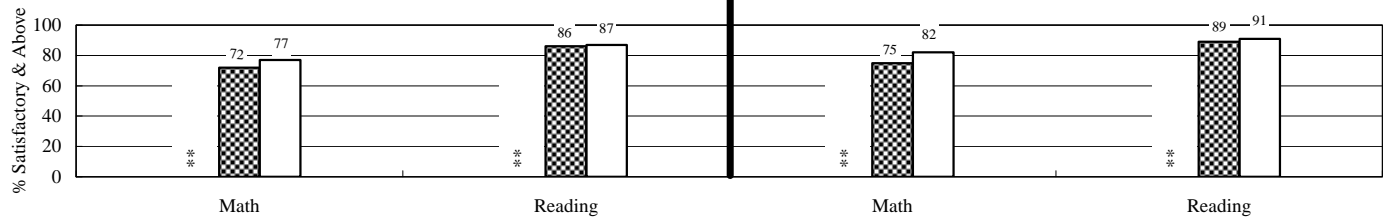

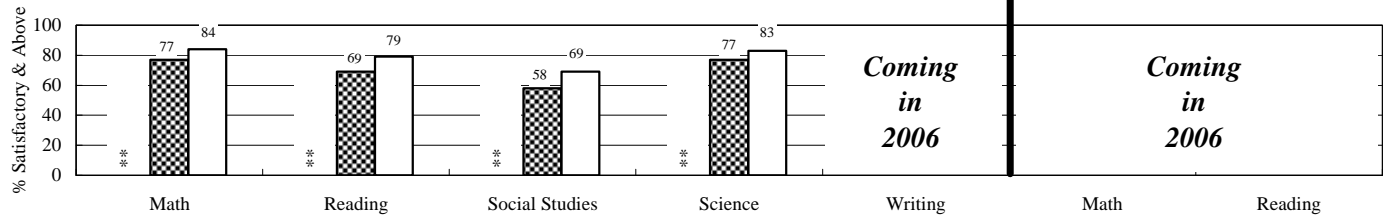
3rd Grade Tests *

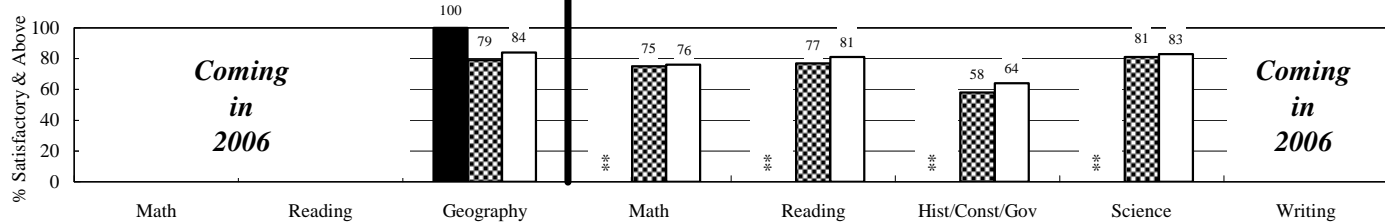

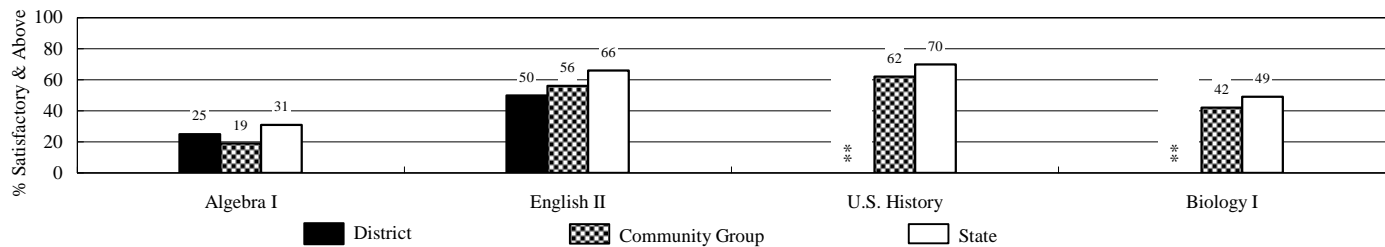
