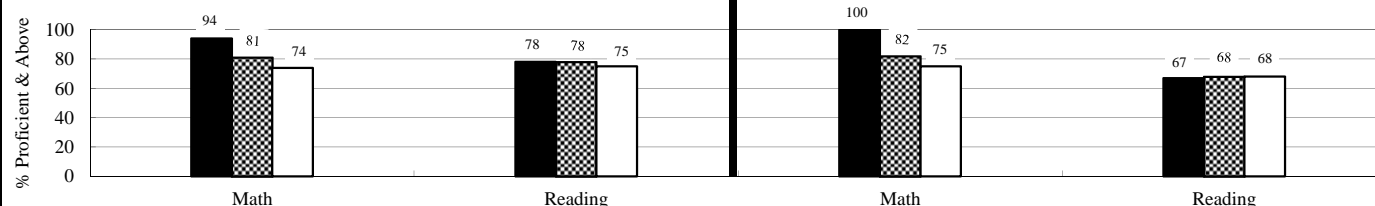

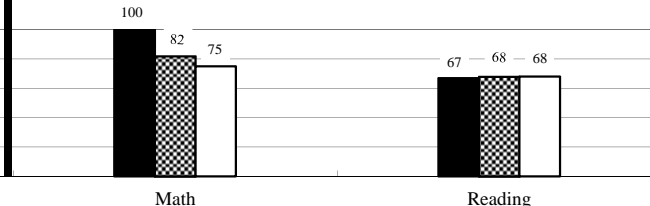

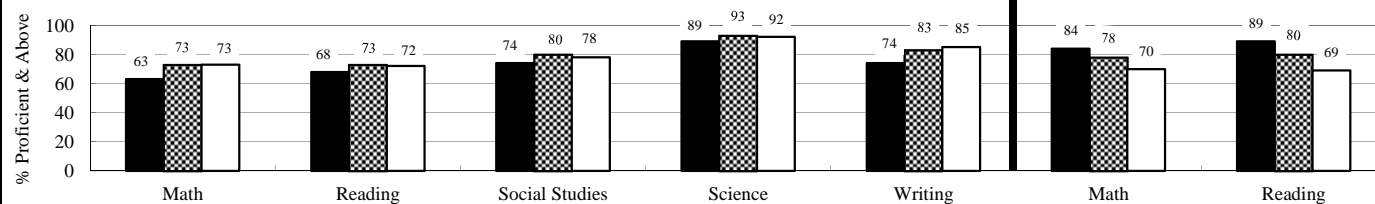
## 3rd Grade Tests\*



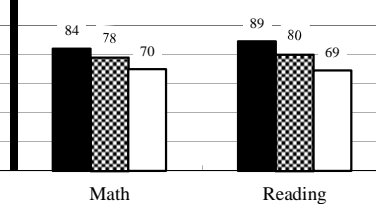
## 4th Grade Tests\*



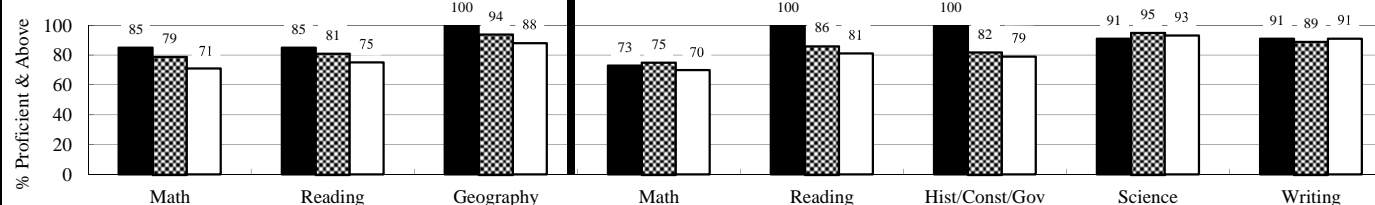
## 5th Grade Tests\*



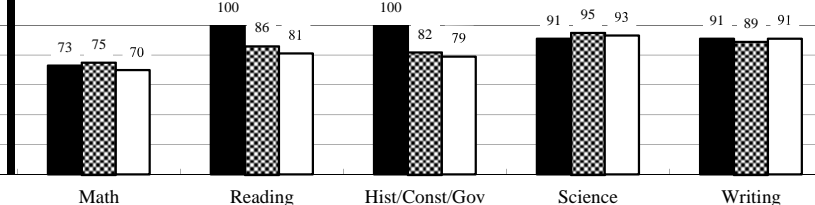

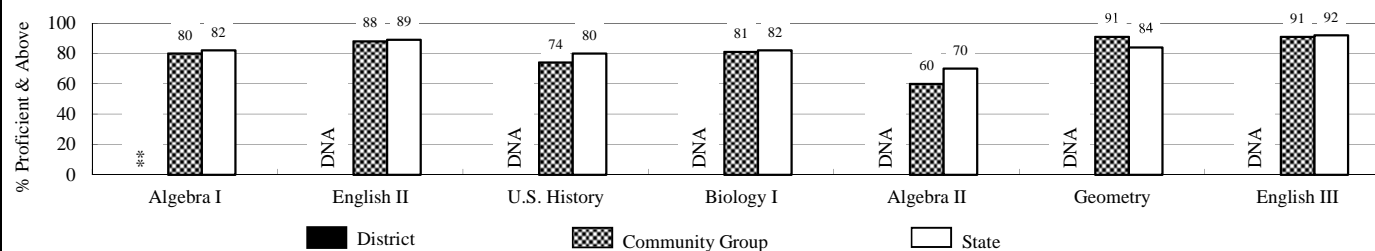
