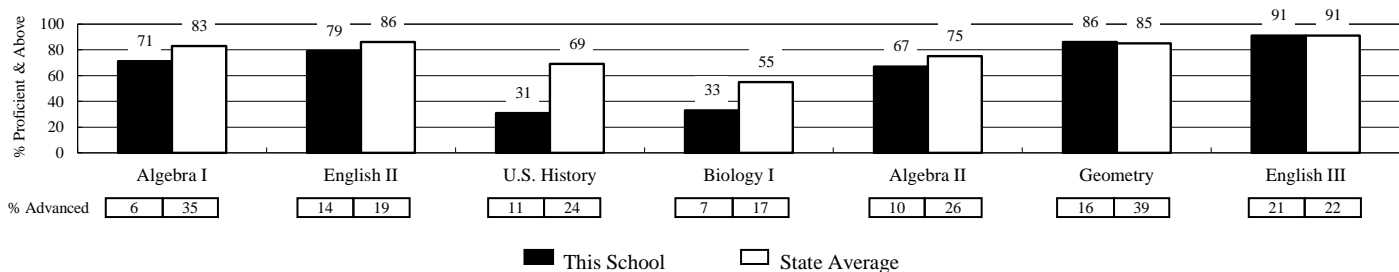

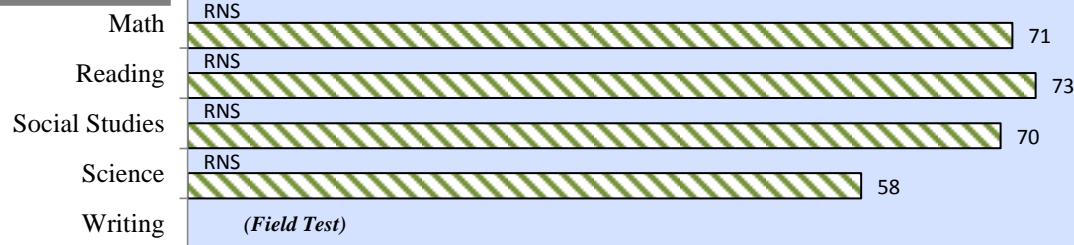

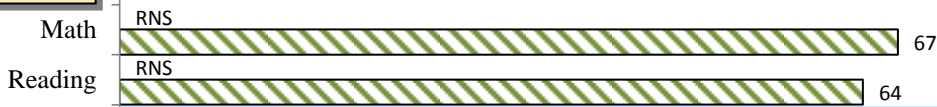
4th Grade Tests

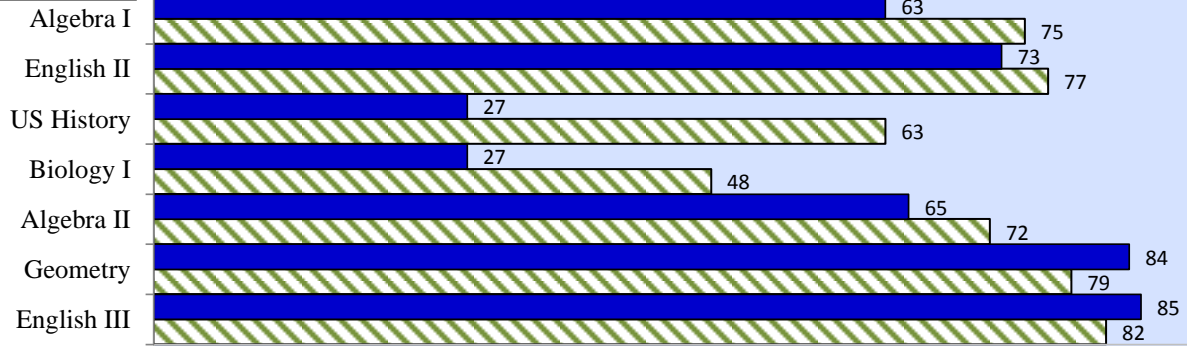
