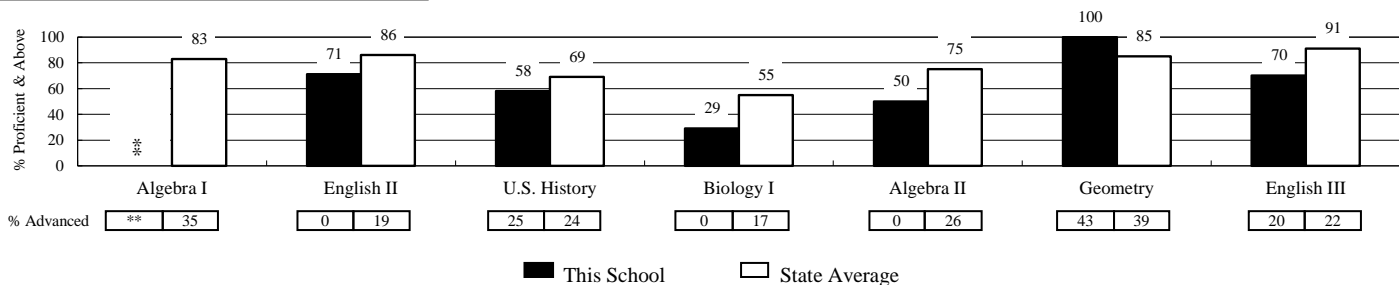

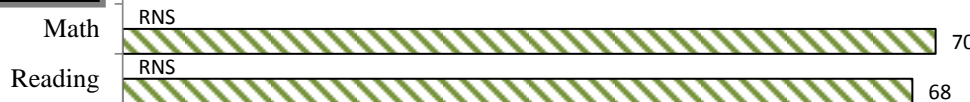
**% of Students Scoring Proficient and Above by Grade and Subject**

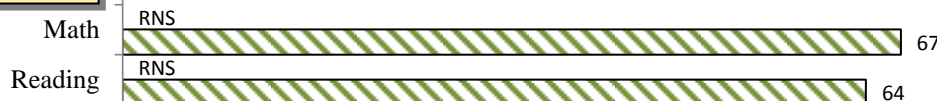
**4th Grade Tests**

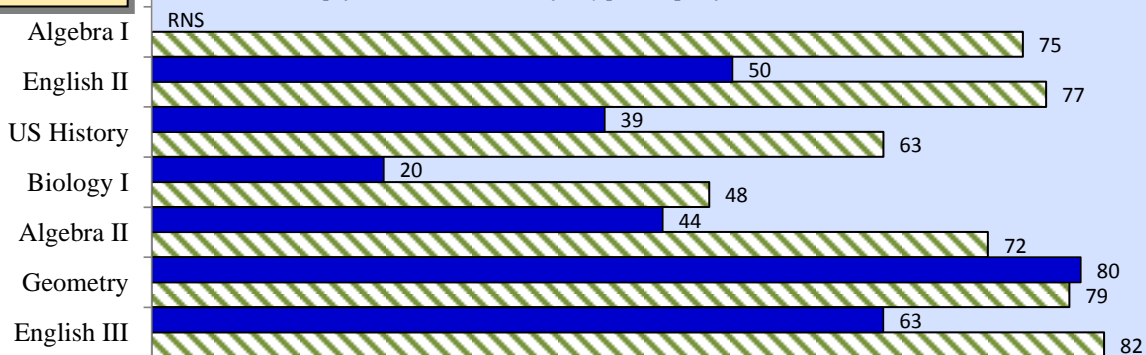
